This document does not account for any tail water and/or sub irrigation that may or may not benefit any parcel.

Hartbauer 1 – 1.5 cfs on 50 acres of 120 acres. Decreed acreage in:

Parcel 1 - 16 acres of 40 acres decreed in the south half of parcel 1

Parcel 12 – 32 acres of 78 acres decreed in parcel 12

Parcel 2 – 2 acres of 2 acres on the very norther strip of the parcel 2

Hartbauer 1 will run the full 1.5 cfs on a rotation basis set by the 3 owners of parcel 1, 12 and 2 parcel 12, alternating the full right.

Hartbauer 2 - 0.83 cfs on 20 acres

Parcel 1-5 acres within the decree

Parcel 12 – 15 acres within the decree

Hartbauer 2 will run the full .83 cfs on a 2 day rotation basis set by the 2 owners of parcel 1 and parcel 12.

Hartbauer 3 – 0.41 cfs on 10 acres

Parcel 1 - 10 acres as decreed only in parcel 1

Hartbauer 4 – 0.20 cfs on 12 acres **twin water right with Hartbauer 5

Parcel 1 – 12 acres as decreed only on the north half of parcel 1
